House of Refuge provides transitional housing and wrap around services for families experiencing homelessness. Every night, families experiencing homelessness find safety, stability, and hope at House of Refuge. Your gift does more than provide a roof—it surrounds families with case management, employment support, education, and the tools they need to rebuild their lives. 90% of the families who complete our program move into stable housing and stay there. When you give, you help break the cycle of homelessness and create lasting change—one family at a time.

Volunteers can support after-school youth programming in the Community Center, help sort and organize donated goods or assist families in the Donation Center, or serve in the Employment & Education Center to help residents build job skills and confidence. There are also roles as Ambassadors to promote the mission in the community, group volunteer projects like painting and landscaping, and opportunities to help plan or staff fundraising efforts. To get started, you can schedule a Volunteer Tour, complete a volunteer application on our website and connect with the volunteer coordinator to find the best fit for your interests and schedule.
