College Bound AZ bridges the education crisis in AZ for low-income, First Generation and special needs students who have a dream of going to college but need help to go to and through higher education. We have developed a successful education support system with proven success. Our students have access to computer labs, coaches, college tours and funding to achieve college completion and earn STEM careers. Your donation makes a difference and supports College Bound AZ's fight to improve education achievement.

Monetary donations are accepted via: Venmo, Cash, Check, Website, and Credit Card.

Who does your agency serve?

Disadvantaged youth ages 14-25. These are low-income, First Generation and special needs students.

Do you need volunteers?

We seek mentors who can help review students' essays, help with Letters of Recommendation, and help with scholarship searches at least November through March annually. This requires obtaining a background check

Do you accept non-cash donations?

We accept non-perishable food (pasta, canned goods, cereal, rice, beans, baby food and cookies, crackers, and granola bars). We also accept hygiene products (razor and shaving cream, toothbrush, toothpaste, deodorant, combs, nail clippers, sanitizing wipes, lip balm, hand sanitizer, shampoo, feminine products, diapers). Typically, a business does a collection drive at their location and we will pick up. We accept used laptop computers that have webcams which we can have refurbished for distribution. If we are preparing for a silent auction, a variety of items are accepted that allow us to fundraise.

How else can people support your organization?

We work with 8th grade students who march in the Veteran's Day Parade. Having veterans to help teach how to respect the flag during and after a parade would help educate youth about veterans and flag etiquette. We need volunteers to coordinate food and hygiene drives with the local Boy Scouts, Rotaries, Kiwanis, or other civic group or write mini grants to help stock the pantry at Mesa Community College.



Every year thousands of youth are removed from unsafe situations and are placed with extended family members or strangers in a foster home. Helen's works to ensure that these children are provided with essentials like clothing, shoes, hygiene supplies, and anything else they need to feel safe and valued. Our event JaKelle's Christmas Box provides gifts, books, stuffed animals, and stuffed stockings to thousands of youth each year. All items are provided free to reduce the financial impact on the foster and kinship families.

Foster and kinship children in the state of Arizona.


