- SB 1184: transportation department; continuation; prohibitions
Continues ADOT with notable restrictions.

+ SB 1412: shoplifting; prior offenses (Vetoed)
Increases penalties for a person who commits shoplifting and has previously committed or been convicted of certain outlined offenses.

+ SB 1456: CTEs; in-demand programs; funding
Requires annual compilation of a draft, statewide, in-demand, education list.

+ SB 1495: personal property exemption; increase
Increases the business personal property tax exemption to \$500,000.

+ SB 1496: property tax exemptions; inflation adjustment
Modifies the method used to annually increase the property assessment limit.

+ HB 2004: utilities; electronic filings; corporation commission (Passed – Chapter 17) Allows a utility to electronically submit applications to the Arizona Corporation Commission.

+ HB 2037: department of transportation; continuation
Continues ADOT for eight years.

+ HB 2040: event online ticket sales (Passed – Chapter 129)
Outlines prohibitions related to bots to make certain online ticket sale purchases.

+ HB 2210: state agencies; continuations; duties (Passed – Chapter 206)
Continues the ACA for five years.

+ HB 2282: unemployment; requirements; disqualifications; shared work
Requires DES to cross-check the validity of UI claims against data sets.

- HB 2309: GPLET: agreement posting; abatement period (Vetoed)
Reduces the GPLET property tax abatement from eight to four years.

+ HB 2379 / SB 1057: internal revenue code; conformity (Passed – Chapter 7)
Conforms Arizona tax statutes to federal law for 2025.

+ HB 2438: ADOT; continuation; administration; licensing; planning (Passed – Chapter 208) Continues ADOT for eight years.

- HB 2570 / SB 1112: planning; home design; restrictions; prohibition (Vetoed)
Prescribes restrictions on municipalities relating to home design and minimum development standards for single-family homes.

+ HB 2634: department of revenue; reuse zone (Passed – Chapter 34)
Transfers the designation of military reuse zones from the Arizona Commerce Authority to the Department of Revenue.

+ HCR 2065 / SCR 1047: expenditure limit; school districts; authorization
Allows school districts to exceed the aggregate expenditure limitation.

+ HJR 2001: Phoenix-Mesa gateway airport; reuse zone
Continues the Phoenix Phoenix-Mesa Gateway Airport Military Reuse Zone until 2031.
